# Remark 3 – Extra information required if the proposed facilities are not permissible under the lease conditions of a private lot or the tenancy agreement of a Short Term Tenancy

If the proposed facilities are not permissible under the lease conditions of a private lot, a waiver may be required to permit such facilities or other aspects of breaches as the case may be, such as gross floor area, height, etc. subject to payment of administrative fee and waiver fee to be assessed. Application for waiver should be submitted to the Lands Department together with the following basic requirements in support of the application:

(i) A copy of a computer printout containing the current ownership particulars of the premises<sup>(1)</sup>;

- (ii) If submitted by an agent, a written authorization from all the registered owners and prospective purchasers<sup>(2)</sup> (if applicable) of the premises;
- (iii) A copy of an up-to-date location / site / floor plan on an appropriate scale showing the premises;
- (iv) Two sets of drawings on an appropriate scale detailing the proposed structures, installations, facilities including the size / dimensions of plant or equipment room / shelter, the area covered by the plant, equipment, installations, etc. (which may or may not be housed in a plant / equipment room or sheltered) and the area of the base supporting such plant, equipment, installations, etc.

If the proposed facilities are not permissible under the tenancy agreement of a Short Term Tenancy, application for a supplemental agreement may be required to permit such facilities or other aspects of breach (if any) subject to payment of administrative fee and revised rent to be assessed. Application for such supplemental agreement should be submitted to the Lands Department together with the information / documents at (ii) to (iv) above.

#### Notes:

- (1) Premises include all premises (including the rooftops and external walls) of the building(s) under the waiver application.
- (2) A prospective purchaser is an intending purchaser under an existing Agreement for Sale and Purchase registered in the Land Registry.
